## **Notice at Collection to Employees and Job Applicants**

TRI HoldCo family of companies collects certain types of personal information from you, the employee/job applicant, as an inherent part of the employment relationship and/or hiring process. Business purposes for collecting personal and sensitive employment-related information:

- 1. Recruiting and retaining employees.
- 2. Collecting and processing employment applications, including confirming eligibility for employment, background and related checks, and onboarding.
- 3. Employee benefit plan and program administration.
- 4. Leave of absence administration.
- 5. Compensation administration and compliance, including payroll, bonuses, reimbursements, invoices, etc.
- 6. Maintaining personnel records and complying with record retention requirements.
- 7. Communicating with employees and/or employees' emergency contacts and plan beneficiaries.
- 8. Facilitating and administering the use of the company's property and resources, including the company's information systems, electronic devices, and network data, and preventing unauthorized access to such.
- 9. Workplace health and safety compliance.
- 10. Ensuring employee productivity and adherence to policies and agreements.
- 11. Investigating complaints, grievances, and suspected violations of policy.
- 12. Complying with applicable state and federal laws, including labor law, employment, tax, benefits, workers compensation, disability, equal employment opportunity, workplace safety, and related laws.
- 13. Exercising and defending legal claims.
